Resolution EC 26-61

Title: Approval of Sole Source Standard Service Agreement for Housing Construction Staff in Craig, Alaska

WHEREAS, the Central Council of Tlingit & Haida Indian Tribes of Alaska (Tlingit & Haida) is a federally recognized tribe with more than 38,000 citizens; and

WHEREAS, pursuant to the Tlingit & Haida Constitution, the Executive Council is the governing body of Tlingit & Haida when the Tribal Assembly is not in session; and

WHEREAS, the Tribal Assembly is not in session; and

WHEREAS, Tlingit & Haida entered into a sole source standard service agreement (Agreement) with Craig Tribal Association d/b/a Aimee's Rentals (Contractor) in order to procure six rooms from the Contractor to house Tlingit & Haida staff working on the construction of the Prince of Wales Early Education Campus from June 1 to December 31, 2025, for a total purchase price of \$178,155; and

WHEREAS, Tlingit & Haida and the Contractor amended the Agreement on September 3, 2025 to account for a room rate increase for a total purchase price of \$184,575; and

WHEREAS, Tlingit & Haida and the Contractor amended the Agreement for a second time on December 8, 2025 to extend the term of the Agreement from June 1, 2025 to March 31, 2026 and a total purchase price of \$262,200; and

WHEREAS, prior approval of the Agreement was not initially sought and obtained, as the original and first amended version of the Agreement were valued below the threshold required for approval by Resolution; and

WHEREAS, the funding of the Agreement for the purchase of the rooms came from American Rescue Plan Act funds in order to support the construction of the Prince of Wales Early Education Campus; and



WHEREAS, the funding of the Agreement for the purchase of the rooms to house construction staff supports Tlingit & Haida's infrastructure investment to enhance the Tribe's ability to serve its citizens through the construction of the Prince of Wales Early Education Campus;

NOW THEREFORE BE IT RESOLVED, that the Executive Council of the Central Council of the Tlingit & Haida Indian Tribes of Alaska (Tlingit & Haida) hereby approves of the sole source standard service agreement (Agreement) between Tlingit & Haida and Craig Tribal Association d/b/a Aimee's Cabins in order to purchase room rentals to house Tlingit & Haida construction staff on Prince of Wales; and

BE IT FINALLY RESOLVED, that this Agreement aligns with Tlingit & Haida's mission to support economic development, cultural preservation, and community growth for the benefit of its citizens and the Prince of Wales community through the construction of the Prince of Wales Early Education Campus.

ADOPTED this 15th day of May 2026, by the Executive Council of the Central Council of Tlingit & Haida Indian Tribes of Alaska, by a vote of 5 yeas, 0 nays, 0 abstentions and 1 absence.
