INVOCATION

3rd Vice President Rob Sanderson, Jr. led the meeting in invocation.

ADOPTION OF THE AGENDA

2nd Vice President Will Micklin, moved to adopt the agenda. U/C.

The chair requested to add a Tribal Assembly update by Raeanne Holmes to the agenda. No objection, so ordered.

PUBLIC COMMENT

Public comment was provided by Head Coach Keenan Sanderson and Assistant Coach Jesse Endert with Ketchikan High School's National Ocean Sciences Bowl.

REPORTS

President's Report

The President reported that community visits have been suspended due to a rise in COVID-19 cases. Zoom Meetings will be held for the remaining communities.

The Tribe is in Phase II of its operational plan, where staff are primarily working from home and buildings are closed to the public. Essential workers who need to work from the office must be approved by the Tribal Emergency Operations Center for in office work and must follow COVID-19 screening procedures and protocols to work in the office.

The President also attended a meeting with the U.S. Department of Justice for an updated regarding Missing & Murdered Indigenous People.

General Counsel Madeline Soboleff Levy gave a verbal summary of her written report. Questions were offered.

Office of the President Manager Report

Chief Operating Officer's Report

Chief Operating Officer (COO) Roald Helgesen gave a verbal summary of his written report.

Cares Act relief is nearly complete. Seven thousand payments mailed out, with 500 pending to date.

Tribal citizens were able to apply for the Rescue Relief Program on Monday, August 16, 2021. Supporting documents were not a requirement to apply. There is adequate funding to allow all 34,000 enrolled Tribal citizens to receive \$1,000 if they have been negatively impacted by COVID-19.

The Tribe is establishing an phone operator system, to efficiently manage incoming telephone calls. Questions were offered.

The COO report was paused to provide the scheduled opportunity for public comment regarding the proposed amendments to Title 04 – Child & Family.

Public comments regarding the proposed amendments to Title 04 – Child & Family were provided from 12:00 PM to 1:00 PM.

The Chair called for a brief recess. No objection, so ordered.

Chief Operating Officer's Report

The COO resumed presentation of his written report.

The Re-entry & Recovery Program is working with local clan leaders to provide traditional names for the facilities. The Tribal Child Support Unit has garnished 187 Permanent Fund Dividends from open child support cases. Employment & Training has completed the Mask Making Project; over 10,000 masks by 3 ladies. Questions were offered.

Chief Finance Officer's Report

Chief Finance Officer Theresa Belton gave a verbal summary of her written report. Questions were offered.

Tlingit Haida Tribal Business Corporation Report

Tlingit Haida Tribal Business Corporation Chief Executive Officer Richard Rinehart provided a verbal report on recent activity. Questions were offered.
