President Richard J. Peterson reported that he attended a First Alaskans Institute meeting for Southeast tribes and other organizations to provide dialog on the Tongass National Forest.

He also attended a roundtable with U.S. Department of Commerce Deputy Secretary Don Graves held at the Elizabeth Peratrovich Hall and a meeting with the U.S. Department of Housing and Urban Development Secretary Marcia Fudge.

The President was the keynote speaker at the 37<sup>th</sup> Annual Tribal Court Conference, hosted by Tanana Chiefs Conference. In addition, he attended a Strategic Planning meeting for Tlingit & Haida's Tribal Court. The meeting will be the first session in what is expected to be an ongoing process. The meeting also included Chief Justice Lisa Lang, Associate Justice Aurora Lehr, Associate Justice Cheryl Demmert Fairbanks and Judiciary Committee Chair DonnaRae James.

President Peterson also attended a meeting with Senator Lisa Murkowski. The meeting addressed transboundary issues, the Landless, veterans, sea otters, missing and murdered Indigenous women, and the lack of funding for broadband in Alaska.

The President expressed his continued appreciation and gratitude to the Executive Council and employees who keep perservering during this pandemic.
