### 2025 Tribal Assembly Resolution Tracking

Resolutions submitted by Delegates and Tlingit & Haida Community Councils for consideration during the 2025 Tribal Assembly’s Constitution Convention were deferred to the Executive Council by a majority vote of the Delegates. The Executive Council reviewed and took action on these resolutions at their next regularly scheduled meeting held on Friday, May 16, 2025. Of the 23 resolutions submitted, 20 were adopted and 3 were not adopted.
