Please provide the CCTHITA Tribal Court with proof that the Petition has been provided to the respondent listed. The court can assist with service if requested by Petitioner.

#### After Service has been made:

Once the proof of service is received by the CCTHITA Tribal Court, the clerk will set a hearing date 20 days or more from the date of service. A notice of hearing will be sent by the CCTHITA Tribal Court to everyone identified in the Petition.

## **Before Court Hearing:**

If anyone listed in the Petition cannot attend the court hearing, they may be asked to provide a written response regarding their position of the divorce or provided the opportunity to attend by telephone; which they will share with the petitioner listed in the Petition.
