Resolution EC 22-63

Title: Authorization to Apply for the U.S. Department of Health and Human Services,  
Administration on Aging Title VI Parts A and C

WHEREAS, the Central Council of Tlingit & Haida Indian Tribes of Alaska (Tlingit & Haida) is a federally recognized tribe with more than 34,000 citizens; and

WHEREAS, under Article X of the Tlingit & Haida Constitution, the Executive Council is the governing body of Tlingit & Haida when the Tribal Assembly is not in session; and

WHEREAS, the Tribal Assembly is not in session; and

WHEREAS, Tlingit & Haida over the past thirty years has worked with the Community Elders Program for the improvement of services to Native Elders, which include, Title VI Part A, Nutritional Support Services Program, and Title VI Part C, Caregiver Support Program, funded through the U.S. Department of Health and Human Services, Administration on Aging; and

WHEREAS, Tlingit & Haida is advised of the availability of funds through the Administration on Aging, Title VI Parts A and C funding programs for the period 2023-2026, to continue and expand upon nutritional support services program, and caregiver support program efforts, to serve within the Juneau urban and adjacent areas; and

WHEREAS, Tlingit & Haida will complete a survey in 2023 of existing conditions, unmet needs, and services needed of Native Elders within the designated service area and will use the information to help design the program of nutritional and caregiver services proposed in the 2023-2026 application; and

WHEREAS, Tlingit & Haida intends to apply for the funding to continue carrying out its mission toward assisting Native Elders' with existing conditions, unmet needs, and core services within the designated service area and such funding, which amount will be determined by population, does include the full amount of Tlingit & Haida's federally approved indirect rate; and


NOW THEREFORE BE IT RESOLVED, that the Executive Council of the Central Council of Tlingit and Haida Indian Tribes of Alaska hereby authorizes the Tlingit & Haida President, or designee, to submit, negotiate, execute, and administer any and all documents, including any subsequent amendments, that are required by the U.S. Department of Health and Human Services, Administration on Aging Programs for granting funds to Tlingit & Haida for the proposed Title VI Part A Nutritional Support Services Program and Title VI Part C, Caregiver Support Program.

ADOPTED this 6<sup>th</sup> day of December 2022, by the Executive Council of the Central Council of Tlingit & Haida Indian Tribes of Alaska, by a vote of 6 yeas, 0 nays, 0 abstentions and 0 absences.
