Resolution EC 25-105

Title: Authorization to Apply for a U.S. Department of Justice Development Accreditation Grant

WHEREAS, the Central Council of Tlingit & Haida Indian Tribes of Alaska (Tlingit & Haida) is a federally recognized tribe with more than 38,000 citizens; and

WHEREAS, under Article IV of the Tlingit & Haida Constitution, the Executive Council is the governing body of Tlingit & Haida when the Tribal Assembly is not in session; and

WHEREAS, the Tribal Assembly is not in session; and

WHEREAS, public safety is key to the security, health, and stability of our Southeast Alaska communities; and

WHEREAS, the Village Public Safety Officer (VPSO) program has been effective at promoting and supporting community safety and stability in Southeast Alaska communities; and

WHEREAS, the VPSO program has grown from seven VPSO positions to twelve, stationed in seven Southeast Alaska communities: Angoon, Hydaburg, Kake, Kasaan, Pelican, Saxman, and Thorne Bay; and

WHEREAS, the U.S. Department's of Justice (DOJ) Office of Community Oriented Police Services has announced a grant under its Community Policing Development Accreditation: Supporting Law Enforcement Agencies in Seeking Accreditation Program; and

WHEREAS, Tlingit & Haida intends to apply for up to \$200,000 in funds from the DOJ Development Accreditation Program, and such funding includes the full amount of Tlingit & Haida's federally approved indirect rate; and

WHEREAS, Tlingit & Haida will use this funding to support VPSOs in advancing toward law enforcement accreditation by providing firearms training, access to online learning platforms such as PoliceOne, courses in de-escalation and bloodborne pathogen safety, and enrollment in a certified police academy;

NOW THEREFORE BE IT RESOLVED, that the Executive Council of the Central Council of Tlingit & Haida Indian Tribes of Alaska hereby authorizes the Tlingit & Haida President, or designee, to submit, negotiate, execute, and administer any and all documents, including any subsequent amendments, that are required by U.S. Department of Justice for granting funds to Tlingit & Haida for the proposed accreditation project.


