## Resolution EC 25-112

Title: Authorization to Apply for an Indigenous Tomorrow's Fund Grant

WHEREAS, the Central Council of Tlingit & Haida Indian Tribes of Alaska (Tlingit & Haida) is a federally recognized tribe with more than 38,000 citizens; and

WHEREAS, pursuant to the Tlingit & Haida Constitution, the Executive Council is the governing body of Tlingit & Haida when the Tribal Assembly is not in session; and

WHEREAS, the Tribal Assembly is not in session; and

WHEREAS, Tlingit & Haida seeks to strengthen Indigenous youth leadership, wellness, and cultural connection through a community-based, intergenerational project entitled, Growing Futures: Indigenous Youth Leading Food, Wellness & Cultural Healing (Growing Futures); and

WHEREAS, the project directly aligns with Tlingit & Haida's strategic goals of promoting community wellness, cultural revitalization, food sovereignty, and youth empowerment; and

WHEREAS, Native Americans in Philanthropy - Indigenous Tomorrow's Fund has announced the availability of funds; and

WHEREAS, Tlingit & Haida intends to apply for up to \$30,000 in funds from the Native Americans in Philanthropy for a 12-month project, and such funding includes the full amount of Tlingit & Haida's federally approved indirect rate; and

WHEREAS, such funding will be used to support traditional food harvesting and preparation, culturally grounded wellness activities, intergenerational mentorship, youth-led storytelling, and the development of programming that supports self-determined Indigenous futures;

NOW THEREFORE BE IT RESOLVED, that the Executive Council of the Central Council of Tlingit & Haida Indian Tribes of Alaska hereby authorizes the Tlingit & Haida President, or designee, to submit, negotiate, execute, and administer any and all documents, including any subsequent amendments, that are required by Native Americans in Philanthropy for granting funds to Tlingit & Haida for the proposed Growing Futures project.

ADOPTED this 17<sup>th</sup> day of July 2025, by the Executive Council of the Central Council of Tlingit & Haida Indian Tribes of Alaska, by a vote of 4 yeas, 0 nays, 0 abstentions and 2 absences.
