Resolution EC 25-122

Title: Authorized Signers for Official Tribal Documents

WHEREAS, the Central Council of Tlingit & Haida Indian Tribes of Alaska (Tlingit & Haida) is a federally recognized tribe with more than 38,000 citizens; and

WHEREAS, pursuant to the Tlingit & Haida Constitution, the Executive Council is the governing body of Tlingit & Haida when the Tribal Assembly is not in session; and

WHEREAS, the Tribal Assembly is not in session; and

WHEREAS, the Tlingit & Haida Constitution authorizes the President, and in the absence of the President a designated Vice President, to execute official Tribal documents on behalf of the Tribe; and

WHEREAS, to ensure the operational effectiveness of the Tribe it is necessary to additionally designate members of the Tribe's administration to execute official Tribal documents: and

WHEREAS, Tlingit & Haida is updating the list of authorized signers on official Tribal documents;

NOW THEREFORE BE IT RESOLVED, that the Executive Council of the Central Council of Tlingit & Haida Indian Tribes of Alaska hereby authorizes the following members of the Tribe's administration to sign any and all official Tribal documents:

President: Richard J. Peterson, and when designated by the President:

Jacqueline Pata, 1<sup>st</sup> Vice President; Clinton Cook, Sr., 2<sup>nd</sup> Vice President; Robert Sanderson, Jr., 3<sup>rd</sup> Vice President; William Micklin, 4<sup>th</sup> Vice President; Delbert Kadake, 5<sup>th</sup> Vice President; or Paulette Moreno, 6<sup>th</sup> Vice President;

Primary: Roald Helgesen, Chief Operating Officer; Secondary: Charlene Robertson, Chief Financial Officer; Tertiary: Madeline Soboleff Levy, General Counsel; First Alternate: Gail Dabaluz, Deputy Chief Operating Officer

BE IT FURTHER RESOLVED, that this resolution supersedes all prior resolutions regarding authorized signers for the Tribe.

ADOPTED this 8<sup>th</sup> day of August 2025, by the Executive Council of the Central Council of Tlingit & Haida Indian Tribes of Alaska, by a vote of 5 yeas, 0 nays, 1 abstention and 0 absences.
