Resolution EC 25-163

Title: Authorization to Apply for Environmental Protection Agency State and Tribal Response Program Funding

WHEREAS, the Central Council of Tlingit & Haida Indian Tribes of Alaska (Tlingit & Haida) is a federally recognized tribe with more than 38,000 citizens; and

WHEREAS, pursuant to the Tlingit & Haida Constitution, the Executive Council is the governing body of Tlingit & Haida when the Tribal Assembly is not in session; and

WHEREAS, the Tribal Assembly is not in session; and

WHEREAS, pursuant to EC Resolution 23-91, Tlingit & Haida has successfully applied for and managed an Environmental Protection Agency (EPA) grant from the State and Tribal Response Program (STRP); and

WHEREAS, the STRP grant is used to catalog and inventory contamination sites, identify Brownfield sites, develop public records and initiate assessment activities that will enable Tlingit & Haida to prioritize its level of concern and develop a response plan; and

WHEREAS, the response plan is utilized through the Brownfield process to clean up the hazardous substance, pollutant or contamination for sustainable reuse, expansion and/or redevelopment; and

WHEREAS, Tlingit & Haida has a STRP grant and intends to apply for fiscal year 2026 funding up to \$385,000 from the EPA for a one year project period, and such funding includes the full amount of Tlingit & Haida's federally approved indirect rate; and

WHEREAS, such funding will be used to expand site assessment activities, update the public record, advance Brownfield cleanup planning, and strengthen Tlingit & Haida's ability to support sustainable redevelopment;

NOW THEREFORE BE IT RESOLVED, that the Executive Council of the Central Council of Tlingit & Haida Indian Tribes of Alaska hereby authorizes the Tlingit & Haida President, or designee, to submit, negotiate, execute, and administer any and all documents, including any subsequent amendments, that are required by Environmental Protection Agency for granting funds to Tlingit & Haida for the proposed State and Tribal Response Program.


